Notice of Motion

Council has received a Notice of Motion from Councillor Kennedy requesting that correspondence be sent to Essential Water asking that water restrictions cease.

The notice of motion reads as follows:

That Broken Hill City Council sends correspondence to Essential Water asking that water restrictions be lifted immediately.

Reason for motion:

The Menindee lakes are at 90% capacity and water restrictions need to be lifted to ensure parks, gardens and ovals are watered and lead contaminated dust is kept to a minimal.

Essential Water can have no justification for any level of water restrictions given the current water levels in the Menindee Lakes.

Most properties in Broken Hill have up to 2000ppm lead in the soil, with some areas up to 15000ppm.
