BROKEN HILL CITY COUNCIL REPORT NO. 263/16

SUBJECT: FURTHER NOMINATIONS TO SECTION 355 COMMITTEES 11/9

Recommendation

- 2. That the S355 Asset Committee Framework and the Constitution of the Alma Oval Community Committee be amended to include an additional community representative position on the Alma Oval Community Committee.
- 3. That Council accepts the nomination from Mr Stephen Pascoe as a community representative on the Alma Oval Community Committee
- 4. That Council accepts the nominations from Ms Iris Dobbin and Mr Peter Beven as community representatives on the Community Strategic Plan Round Table Committee.

Executive Summary:

Section 355 of the *Local Government Act 1993* provides that a function of the Council may be exercised:

- (a) by the council by means of the councillors or employees, by its agents or contractors, by financial provision, by the provision of goods, equipment, services, amenities or facilities or by any other means, or
- (b) by a committee of the council, or
- (c) partly or jointly by the council and another person or persons, or
- (d) jointly by the council and another council or councils, or
- (e) by a delegate of the council.

In accordance with Section 355 of the *Local Government Act 1993* Council previously established Committees to assist Council with the operation and management of its parks, ovals and reserves, these are called Section 355 Asset Committees. Council has also previously established Section 355 Advisory Committees to provide advice to the General Manager on specific operations of Council.

Council adopted Asset and Advisory Committee Frameworks and Constitutions as the governance structure by which a Committee operates. Membership on each committee forms part of the constitution and includes the number of community representatives, stakeholder representatives (if any) and Councillor representatives required for each Committee to function effectively.

Report:

As per Council's adopted Asset and Advisory Committee Framework which states that:

 Committees are to be appointed every four (4) years, three (3) months after the Local Government General Election. The term of office for all Committees will be aligned to the term of office of the current Council (four years).

• All positions will be declared to be vacant two (2) months after the Local Government Election.

Council advertised for nominations for community representatives on its Section 355 Committees, with nominations closing Friday, 25 November 2016.

At the close of nominations, 60 nominations were received for consideration and these have been reported to the December Council Meeting at Item Number 10 in the Reports section (Report No. 258/16).

Council has now receive a further three nominations for membership on Committees.

The following table summarises the number of citizen representatives required on each Committee; the number of nominations received; and the number of vacancies should Council appoint all nominees to the respective Committees that are recommended in this report plus Report No. 258/16 (in the Reports Section at this meeting).

PRESENTATION FROM RAZIJA NU'MAN ON BROKEN HILL CITY COUNCIL'S COMMUNITY STRATEGIC PLAN

Councils Corporate Responsibility Officer, Razija Nu'man addressed the committee and outlined the development of Broken Hill City Council's Community Strategic Plan (CSP).

The CSP (a section 355 committee) in Council terms, sits above all other Council plans and policies in the planning hierarchy. Its purpose is to identify the community's main priorities and aspirations for the future and plan strategies to achieve them.

The minimum time frame set by legislation is 10 years. Council's CSP was developed in 2010 and was reviewed in 2013 and extends to 2033. Council has a custodial/facilitation role in initiating, preparing and maintaining the CSP but it cannot by itself, achieve everything in the CSP on its own. So while the legislation mandates quite a lot of requirements from local government, it is actually silent on how the rest of the system is to respond and incorporate CSP objectives and strategies. Hence the creation of the Round Table as one of the methods to involve the relevant partners.

The structure of the CSP follows a 'quadruple bottom line' approach of social, environment, economic and civic leadership.

None of these elements are free standing or separate from the others. They interact. Each has a connection with the other, as each connection is explored, one achieves the 'integration' part of the Integrated Planning and Reporting Model as it is defined in the legislation and as it cascades down into actual actions.

The structure follows a set of agreed principles - equity, access, participation and rights, which have been strengthened by a further piece of legislation The Disability Inclusion Act.

The Community Round Table was initiated in order to get key stakeholder partners and community representatives around the table to each as a team working together in our different spaces heading in the same direction under this Community Strategic Plan for the community.

The efforts of the group are reported in the minutes of Council and captured in the End of Term report at the end of the four year term of Council.

At the end of term of Council, the legislation requires that Community Representatives of all S355 Committees are to re-nominate if they so wish and that Council advertises for membership. It is hoped that current Community Representatives re-nominate for a position on the Round Table for the new term.

Another legislative requirement is that the Community Strategic Plan has to be reviewed. One of the steps of that review will be to contact all stakeholder partners listed against the strategies to seek their views on whether they are still valid and what other strategies need to be included. This information will be gathered along with community views and provided to Council. From that setting, Council will go one step further and develop a full Delivery Program and Operational Program around those strategies.

Executive Summary:

Councillors will be aware of the ongoing discussions initiated about creating a Far West Initiative (FWI) for far west councils. The initiative was in lieu of the broader Fit for Future process undertaken by other NSW local councils over the past 3 years, designed primarily to assess councils' viability as a precursor to the current merger processes being undertaken.

Report:

Attached to this report Councillors will find councils draft submission to the Far West Initiative proposal. The submission date is Friday 16 December.

This paper was circulated to Councillors on Tuesday 6 December 2016 ahead of its formal presentation to Council seeking adoption at the December meeting. The purpose of the circulating the draft submission out of session was to invite comments and feedback from councilors on its content.

The paper presented to the December meeting is unaltered from that which was circulated last week. To date five councilors have provided feedback or comments all of whom have supported the draft submission with two seeking to remove the reference to the new entity being able to access T-Corp funding.

Submission re Far West Joint Organisation

The release of the final Report of the Independent Local Government Review Panel (ILGRP) contained a supplementary paper entitled "Strengthening Far West Communities -A Pathway for Change" which was released some two (2) years ago in October 2013.

The paper was part of the ILGRP's overall review of Local Government in New South Wales and in tandem with the Review of the Local Government Act, in a period of significant change and reform for the Local Government Sector in New South Wales. The first parts of that change have been recently implemented.

The specific issues faced by the Far West of New South Wales was the catalyst for the different approach for the Far West and this in part has led to the formation of The Far West Initiative Advisory Committee (FWIAC) led by John Williams of Broken Hill who was the former Member for Murray Darling.

The process for reform of the Far West has been led by the Department of Premier and Cabinet with assistance from the Office of Local Government.

There has been a series of discussions in relation to the appropriate model to suit the uniqueness of the Far West and to that end UTS developed five possible models for consideration and these were first presented to the meeting at Wentworth on Wednesday 6 April 2016 where the Minister for Local Government Hon. Paul Toole M.P. was in attendance.

It was clear from the meeting that the option to have a Far West Joint Organisation (FWJO) 'type' model was the generally accepted model which sought to retain local councils and local representation supplemented by representatives from the NSW State Government and Federal Government plus designated representation from the Aboriginal Community. The involvement of the Unincorporated Area was unclear.

Purpose

The key issue to the success of the FWJO will be aligned to its purpose and the reduction and ultimate elimination of duplication across the tiers of government.

Funding Models

It is the view of Broken Hill City Council that the NSW Government commit to fund the FWJO for the first five years, directly from the Amalgamation / Merger fund that has been established to assist other NSW Local Government mergers. After this time the FWJO should be self-sustainable, with possible capped contributions from member Councils, subject to a suitable funding arrangement being established.

The FWJO model should not be another cost shifting exercise to local government and should not result in less dollars to councils, in real terms.

There is a potential second option that may involve the FWJO being able to gain access the T-Corp loan facility that would see the FWJO being able to access funds to run its operational and capital objectives and the contribution from councils' might be the repayment of the principal and interest attributable to the loan, spread between the eight councils on a pro rata basis.

The Board overseeing the FWJO would work in unison with the entity to establish an operating and capital budget, from the 'sourced' funds.

Council would not support a model that requires the far west councils to fund the FWJO from within its own revenue sources. The new authority must be able to sustain its own existence with minimal input from councils.

Representation

Representation of the FWJO needs to be able to achieve the ultimate goals of this initiative and genuinely be about improving the lifestyles of our respective communities and ensuring we are all better off under this model. If this model is not going to improve the current situation then we are wasting our time. The people around the table need to be fully committed and engaged in this process and decision makers need to be in the room at every meeting.

The State and Federal appointments to the FWJO must be senior members of their respective agencies with a genuine desire to be engaged. We would then envisage that the eight member councils would be represented by the respective Mayors and then the eight General Managers would be included in an observer capacity to ensure good governance models and outcomes are achieved.

Whichever way you look at this, it will unquestionably fall to the local councils to roll out many of the FWJO initiatives to their local communities so this engagement is paramount.

Position of FWJO Chair

In councils view consideration should be given to two options in relation to the leadership opportunities to direct the FWJO. Firstly there is an opportunity to have the Mayors' of each Council Chair the FWJO on a two year cycle accompanied by the comprehensive training package for Chairs' through the Australian Institute of Company Directors (AICD).

Alternatively council would support an Independent Chair appointment; the appointment however must be consulted and acceptable to the majority of member councils.

A further alternative would be to appoint a Minister for the Far West that would genuinely provide the Far West a voice in the Cabinet room.

Functions

Perhaps the key critical issue surrounding the FWJOC relates to functions it will perform.

Equally important in moving forward will be a clear delineation as to what the roles and functions of the respective entities will be. The basis of the move to a FWJO is to reduce duplication of service provision and to better deliver outcomes to our respective communities.

As a council we have not been clear as to the functions that the new entity will perform. While we can see a model that shares resources between councils, the opportunity for staff exchanges, joint procurement processes to capitalise on economies of scale that might include legal panels, staff secondment to backfill temporary vacancies, regional plans, improved governance frameworks and effective management and to facilitate arrangements such as pooled funding, shared services and innovative procurement, the broader advantage to BHCC may still need to be articulated to justify any council and community outputs that might be required.

Meeting cycles

Broken Hill City Council would suggest a meeting cycle of four meetings of the FWJO per annum, with at least two of the meetings being held in Sydney with access to Ministers, Advisors and bureaucrats being unfettered. These meetings would of course need to be prearranged and could be done so through the FWJO Executive Officer, but the overarching premise would be that government officials be available during these periods that member councils are in Sydney. The remaining meetings could be spread across the region on a rotational basis.

RDA

The NSW State Government may like to consider transitioning the current functions of the Regional Development Authorities, spread across the eight council areas, into the FWJO. This will again seek to ensure that there is consistency maintained across the region.

Aboriginal representation

It is councils understanding that there is provision in the briefing paper for one Aboriginal representative on the FWJO. While council do not profess to know what the 'right' number might be, given the width and breadth of the Far West we are not convinced that one representative is the most appropriate. Perhaps there could be two Aboriginal representatives of the FWJO, one from the north of the region and one from the south of the region.

Executive staff for the FWJO

It is expected that as part of the FWJO that staff will be required to ensure that the organisation is able to achieve its strategic and operational outcomes. The levels of required funding attributable to the FWJO should be commensurate with the staff numbers required to ensure its success and of course fund the activities of the organisation. The impost on member councils should be limited to the absolute minimum.
