That Broken Hill City Council sends correspondence to the NSW State Government and the opposition requesting that the NSW State Government legislates that Broken Hill is not responsible for any costs associated with the delivery of water via the Wentworth to Broken Hill pipeline and that the NSW Government cover the costs for the life of the pipeline.
 - That having the State Government of the day decide whether they subsidise the pipeline costs will cause great uncertainty in the community and to have the Broken Hill community begging the State Government every four years to pay a \$30m subsidy is unacceptable and impractical.
- 3. Also that each of the candidates for the State election in our electorate is contacted to get a written letter of support for legislation so that the Broken Hill community does not pay for any costs associated with the delivery of water from the Wentworth to Broken Hill pipeline.
