- 2. That correspondence from Canterbury Bankstown Council dated 5 September, 2018 advising of their Council resolution to provide a drought relief donation of \$10,000.00 to be shared between Broken Hill and Cobar, be received.
- 3. That Council sends a letter of appreciation to Canterbury Bankstown Council for their generous donation.
- 4. That Council staff continue to liaise with local community welfare organisations, in conjunction with Canterbury Bankstown Council, to determine how the funds will be best utililised to benefit the community.

Executive Summary:

Council has received correspondence from Canterbury Bankstown Council advising of a Mayoral Minute passed at their August Council Meeting to provide financial support to the communities of Broken Hill and Cobar due to the current drought conditions.

The donation of \$10,000.00 is to be shared equally (\$5,000.00 each) between Broken Hill and Cobar. Discussions will be held with Canterbury Bankstown Council to discuss the various welfare services/drought relief programs that could benefit from a donation of \$5,000.00 and determine the best outcome for the community.
