### **Notice of Motion**

- 1. That Motions of Which Notice has been Given No. 5/19 dated March 22, 2019, be received.
- 2. That Broken Hill City Council donates \$5,000.00 to Silverlea Early Childhood Services Inc. (Silverlea) to keep this important service operating in Broken Hill while they wait for government funding.
- 3. That Broken Hill City Council writes to the appropriate Ministers both State and Federal explaining the importance of Silverlea past, present and future and the impact the closure of this service will have on the community as a whole and the many families that rely on it.

### **Summary**

Council received a Notice of Motion from Councillor Kennedy on 22 March 2019 regarding financial assistance to Silverlea Early Childhood Services Inc. (Silverlea). The Notice of Motion is as written above.

Councillor Kennedy's Notice of Motion is attached.

### **General Manager's Comment**

There has not been any background information provided to assist management to provide informed advice to Council in relation to this matter. The nature of the business operations, the current funding model, the changes that have occurred to the operation that has led to the current situation, the likelihood of government funding being received given the changes in the provision of federal funding through the introduction of the NDIS and the ongoing viability of the operation, are all unknowns at this time. Council should be seeking this base level of information before seeking to commit public funds.

Council have previously treated such requests with a resolution to refer the matter to the Community Assistance Grants (CAG). Upon receipt of correspondence from Silverlea earlier this month seeking a donation, advice was provided to Silverlea to make an application through the CAG. Silverlea would have been eligible to apply in the last round of Community Assistance Grants.

### **Executive Summary:**

At Council's Ordinary Meeting held 20 February 2019, Council considered a report regarding a proposal from Water NSW to transfer two allotments to Broken Hill City Council upon completion of the Murray to Broken Hill pipeline. Water NSW purchased the land from Perilya and installed a new pipeline across the land.
