SUBJECT: PROPOSAL FOR DUAL NAMING OF THE DARLING RIVER 11/426

Summary

The Barkindji Native Title Group Aboriginal Corporation has made application to the Geographical Names Board for the dual naming of the Darling River as Baaka.

Public comment is being sought by the Geographical Names Board on the proposed dual name of the Darling River as Baaka for the extent of the Darling River commencing approximately 39km North East of Bourke, winding through Bourke, Wilcannia, Menindee, Pooncarie and Wentworth where it joins the Murray River.

Public comment closes on 28 January 2020.

The Darling River has been known as the Baaka by Barkindji people for thousands of years.

The dual naming of the Darling River as Baaka will reflect the significance of the river to the Indigenous communities that live along it and recognises the historical name of the river.

I call upon my fellow Councillors to support the proposal in order for the historical name for the Darling River to exist side-by-side with the European name.

Recommendation

- 1. That Mayoral Minute No. 1/20 dated December 20, 2019, be received.
- 2. That Broken Hill City Council supports the proposal for the dual naming of the Darling River to be also named the Baaka.
- 3. That Council sends a correspondence to the Geographical Names Board advising of Council's support for the dual naming of the Darling River.

Geographical Names Act 1966

The Geographical Names Board is seeking public comment on a proposal by the Barkindji Native Title Group Aboriginal Corporation to dual name the Darling River as Baaka. Feedback is sought on the proposed dual name including the spelling and geographical extent.

The proposed dual name is for the extent of the Darling River, commencing approximately 39km NE of Bourke, winding through Bourke, Wilcannia, Menindee, Pooncarie and Wentworth where it joins the Murray River.
