Ms Barbe also raised concerns regarding the elderly members of the community who have fruit trees but are incapable of carrying out the work or have the finances to buy their own traps to eradicate the pest and asked Council to look at providing/subsidising traps for the community.

The Mayor advised Ms Barbe that Council would consider a report at this meeting regarding the formation of a Fruit Fly Working Group, Chaired by Councillor Page, which would also include community representatives who are knowledgeable in the areas of agriculture/horticulture to assist Council to deliver a whole of town approach to combatting fruit fly.
