# Verbal Report by the Deputy Mayor - Regional Cities Sydney - 6 August 2025

The Deputy Mayor gave a verbal report and thanked the Mayor and Councillors for the opportunity for the General Manager and himself to attend the Regional Cities meeting and the Country Mayors Meeting in Sydney from 6-9 August.

The Deputy Mayor advised that the Regional Cities Meeting was very informative and the Secretariat Services had a very good reception and the ability to get meetings with numerous Ministers.

There are 16 Regional Cities and the Deputy Mayor and GM met with numerous Ministers.

Minister Moriarty was to meet with them on 6<sup>th</sup> August, however, she didn't turn up at the meeting. Premier Minns seen the group standing near the Ministers Office and asked what they were doing and it was explained that Minister Moriarty didn't attend the meeting and the Premier requested that they go to his boardroom and he would meet with them which the Deputy Mayor commended him for.

The Deputy Mayor had the opportunity to speak to the Premier first and he advised him of Council's desperation for funds to upgrade the Airport Tarmac. He advised the Premier that Council have been refused twice by Federal Government and that Council had received a letter of support from his office however, it is our belief that the Federal Government is looking for a monetary contribution from the State Government. The Deputy Mayor asked if they could see their way clear to commit to a \$3M contribution. Premier Minns questioned the reasoning and following a long discussion he advised he will personally follow it up and talk to Treasury.

The group also met with the Treasurer Dan Mookey and Regional Cities Chair Steve Krieg asked that Deputy Mayor Hickey speak about Council's request to the Premier. The Deputy Mayor advised the Treasurer that the Premier virtually approved \$3m and it was a matter to get it from Treasury and Minister Mookey suggested he could give me a virtual cheque. The Treasurer then advised on a more serious note he was quite prepared to look at the proposition as he realised the huge need for remote City airports and the important need for the RFDS.

The General Manager is following up these requests with letters to the Premier and Treasurer.

Chairman Steve also asked me to speak to Minister Whan who is the Minister for Tafe and explain how following the halting of the decision to remove the milling machines and lathes from Broken Hill, that Council have now set up an Industry driven working group comprising of Industry, Tafe, Council, RDA and Career Advisors from schools and that we now have two tradesman completing their Cert IV Certificates to enable them to be able to teach next year and the Engineering Industry have 12 prospective apprentices to commence in 2026. The Minister questioned the Deputy Mayor on how it worked and was very impressed. Minister Whan said he would be using it as a Model at a forum in Wagga later this month. Steve Krieg also advised me he would be using it as a model for a forum in Lismore.

Chairman Steve moved a motion that the Regional Cities submit a report in support of Broken Hill to the State Government to commit to help funding for our airport upgrade which was supported unanimously.

This is a very strong group which has the attention of most of the Ministers and the Deputy Mayor feels very privileged to have such a strong support from the Chair and all of the Regional City representatives.

# Country Mayors 9 August 2025

The Deputy Mayor thanked Council for the opportunity to attend this forum.

The major focus of the Country Mayors was regarding Regional Crime. The Minister for Police Yasmin Catley, addressed the group and gave a very informative address. The Minister explained the initiatives offered to try to fill outstanding Police positions including paying prospective officers to attend the Goulburn Academy, offering huge incentives to officers to take up remote positions and the chance for new police officers to return to their home towns straight from the academy.

Assistant Commissioner Bret Greentree gave an address and showed the crime stats over the past months showing a reduction of crime in most areas with a good result for the Far West.

It would appear that the Courts are not on the same wave as the Police which is really disappointing.

The Chief Magistrate for NSW then addressed the forum and it was very obvious that the system is broken between the Law enforcement and the Courts.

A dinner was also held which was attended by former Prime Minister, Tony Abbott and he gave an excellent presentation and then went to all tables to say hello.

Organisations who did received funding in the previous financial year will still be eligible to apply in the following financial year; however, their applications will only be considered if funding has not been fully allocated (to applications that receive a successful assessment score) following the assessment of biennial applications (applications from organisations who did not receive funding in the previous financial year).

That In One Accord be an exception to this clause, as per Minute No. 47872, in that they can apply annually for a grant towards Carols by Candlelight and their application is assessed in the priority group each year.
