## **CHRISTMAS IN PATTON STREET PARK 2022**

## STALLHOLDER APPLICATION AND AGREEMENT

Christmas in Patton Street Park to be held on 26 November 2022, 4pm to 8pm.

Patton Street Park is a Broken Hill City Council venue and is hired under agreement by Patton Village Association for this event.

**Stall Cost:** Non powered 3x3m<sup>2</sup> market stall sites are available for \$10 per site.

## **Public Liability Insurance:**

- Stallholders must provide a current Public Liability Certificate of Currency for \$20 million.
   Stallholder's Certificates of Currency will be supplied to Broken Hill City Council at Council's request; or
- A stallholder who is a current financial member of Patton Village Association can be covered by Patton Village Association's Public Liability Insurance, should a claim arise the excess is payable by the stallholder. Stallholders with food cooking or warming equipment are not eligible for Public Liability coverage through Patton Village Association. Please note: Patton Village Association's Public Liability covers the lessee of the stall only, additional persons engaged on the stall are not covered by Patton Village Association's Public Liability unless they are a financial member of Patton Village Association.

Alcohol and Smoking: Patton Street Park is an Alcohol Free zone and No Smoking area.

Patton Village Committee Marshall: Follow instructions of the Patton Village Committee Marshall at all times.

**Anchoring of Marquees, Tents and other Objects:** Pegs must not be used as anchorage of marquees, tents or other objects. Sandbags or other purpose-built items are permitted.

**Vehicles:** Vehicle entry into Patton Street Park is for unloading/loading purposes only, vehicles must vacate the park at all other times (excluding Santa's Sleigh and associated towing vehicle). Vehicle entry is through the front gates on Patton Street and exit through the rear Wilson Street gates. Driving is only permitted on bitumen paths.

Vehicular movement within Patton Street Park (excluding Santa's Sleigh and associated towing vehicle) is restricted from 2pm to 3.30pm and after 8pm.

If your vehicle is integral to your stall and you wish the vehicle to remain in the park during the event, please provide full details of the vehicle and outline why it is integral for the vehicle to remain in the Park for the duration of the event to the Market Coordinator who will negotiate with Broken Hill City Council for vehicular approval. Market stall site booking will only be approved if the vehicle remaining in the park for the duration of the event is approved by Broken Hill City Council.

**Food Vendors:** Food vendors must comply with <u>NSW Food Authority Guidelines for Food Businesses at Temporary Events</u> which is available on the NSW Food Authority website.

Live animals: No live animals are permitted for sale.

**Balloon Release:** Balloon releases are not permitted during the event.

**Cleaning:** Sites must be left in a clean and tidy state.
